

SCRATCH AND SAVE OFFICIAL RULES AND REGULATIONS

PROMOTION PERIOD SEPTEMBER 1-30, 2017

1. **No purchase necessary** to receive a Scratch & Save Card ("Card").
2. **Cards are available** while supplies last and may be redeemed only at Powell Plumbing Supply, a division of Emco Corporation ("Powell Plumbing Supply") on the dates of the promotion. Only one Card may be obtained per person or company per day. Cards are not transferrable and are redeemable only by the person or company who obtained the Card.
3. **Promotion period:** The promotion runs from the opening of business on September 1, 2017 until the close of business on September 30, 2017.
4. **To participate:** Must be 18 years or older and a resident of Ontario to participate in the promotion and receive a discount. Ask for a Card at check-out. Rub off the complete silver area on the Card to reveal the discount. If any part of the silver area is revealed prior to being scratched in front of the cashier, the Card is void.
5. **To Redeem a Discount:** Only one Card may be redeemed per person or company per day. Cards must be submitted to cashier at the time of check-out. The instant discount revealed on the Card applies to the current purchase. All discounts must be used at time of receipt of Card. No adjustments will be made to previous or subsequent purchases. Discount may not be combined with any other offer or discount.
6. **Discount will be applied to cash and carry merchandise only.** Layaways, special order products, and house accounts do not qualify. Discounts must be accepted as awarded, with no substitutions, and are not redeemable for cash.
7. **There are no prizes.** Only Cards are offered.
8. **Discounts and Odds:** Each Card will reveal a discount. 2,500 Cards have been printed. Approximate odds of receiving each discount are: 5% off - 60% (1,500 Cards); 10% off - 33.2% (830 Cards); 15% off - 5% (124 Cards); 20% off - 0.8% (20 Cards); 25% off - 0.4% (10 Cards); 30% off - 0.4% (10 Cards); 40% off - 0.2% (5 Cards) and 50% off - 0.04% (1 Card). The number of discounts available will diminish as the Cards are claimed.
9. **Merchandise returned** from a purchase with a discount may be exchanged or returned subject to Powell Plumbing Supply's standard return/exchange policies. Refunds will be made in the original form of payment only.
10. **All Cards are subject to verification.** Each Card may be used only once. Submitted Cards remain the property of Powell Plumbing Supply.
